1. Cardholder who wishes to participate in the China Fast Track™ Service ("the Service") provided by Bank of Communications Co., Ltd. Hong Kong Branch ("the Bank") shall fill in this application form. The Service is applicable in Hong Kong, Macau and Mainland China only.
2. The Service is applicable to principal and/or supplementary cardholders of CUP Dual Currency Diamond Card / Platinum Card issued by the Bank in Hong Kong and such other cardholders as may be designated by the Bank from time to time ("the Cardholder").
3. The information on this application form provided by the Cardholder will be given to China Fast Track™ provider, Superior Travellers Services Limited for the provision of the Service.
4. The fee of the Service in each trip used by the Cardholder and his/her companion(s) is at HK\$750 per trip (counted per head). The Cardholder is required to book the Services for his/her own and his/her companion(s) at least 4 working days before boarding via fax to the Bank. The Cardholder will be unable to use the Service if booking is not made in advance. The service fee will be debited from the Cardholder's HKD account of principal CUP Dual Currency Diamond Card / Platinum Card. To change or cancel the Services, the Cardholder is required to notify Superior Travellers Services Limited by email or fax for the necessary arrangement at least 1 working day before boarding. Late cancellations will be charged at full standard rate. No show is considered a fulfilled service and full standard rate will be charged.
