Terms and Conditions of Bank of Communications Credit Card Travel Reward Program

1. Bank of Communications Credit Card Travel Reward Program (“Travel Reward Program”) is applicable to principal cardholder (“Cardholder”) of Bank of Communications Platinum Credit Card, Go-Goal Credit Card, MI Credit Card, Co-branded Credit Card issued by Bank of Communications Co., Ltd. Hong Kong Branch (“the Bank”) in Hong Kong and such other cardholders as may be designated by the Bank from time to time, excluding Platinum Credit Card with cash rebate program as reward program, Pacific Credit Card, Pacific Internet Card and Gift Card.
2. Cardholder must be the member of participating partners of the Travel Reward Program in order to redeem the credit card bonus point reward (“Bonus Point”) to miles or points. Cardholder who wishes to join the membership of frequent flyer program of the participating partners can register via their websites. The participating partners of the Travel Reward Program include “Air China”, “China Eastern Airlines”, “China Southern Airlines”, Asia Miles or such other participating partners designated by the Bank from time to time.
3. The credit card account of Cardholder must maintain good credit status and are valid at the time of redeeming Bonus Point to the miles or points. Otherwise, the Bank has the right to cancel any redemption request of the Travel Reward Program without prior notice. The terms and conditions of the bonus point programs of the Bank are subject to the terms and conditions of “Credit Card Bonus Point Reward Program” of the Bank.
4. Cardholder can redeem 1 mile of Air China or China Southern for 8 Bonus Points. The first time redemption should be at 8,000 Bonus Points for 1,000 miles and 4,000 Bonus Points for 500 miles for thereafter redemption.
5. Platinum Credit Cardholders and CUP Dual Currency Diamond Card Cardholders can redeem 1 Eastern Miles Point for 8 Bonus Points. The first time redemption should be at 8,000 Bonus Points for 1,000 Eastern Miles Points and 4,000 Bonus Points for 500 Eastern Miles Points for thereafter redemption.
6. Platinum Credit Cardholders can redeem 1 Asia Mile for 12 Bonus Points. The redemption unit of Asia Miles will be 6,000 Bonus Points for 500 Asia Miles.
7. CUP Dual Currency Diamond Card Cardholders can redeem 1 Asia Mile for 8 Bonus Points on or before 31 December 2011. The redemption unit of Asia Miles will be 4,000 Bonus Points for 500 Asia Miles.
8. Gold and Classic Credit Cardholder can redeem 1 Eastern Miles Point for 12 Bonus Points or 1 Asia Mile for 15 Bonus Point. The first time redemption should be at 12,000 Bonus Points for 1,000 Eastern Miles Points and 6,000 Bonus Points for 500 Eastern Miles Points for thereafter redemption. The redemption unit of Asia Miles will be 7,500 Bonus Points for 500 Asia Miles
9. If the Bonus Points are insufficient for redemption of designated miles or points of the Travel Reward Program, the Bank has the right to cancel the redemption request without prior notice.



10. The miles or points redeemed via the Travel Reward Program can only transfer to principal cardholder's membership account of the participating partners of the Travel Reward Program and cannot redeem to membership account of supplementary cardholder or other members.
11. The handling charge for each redemption of Asia Miles is HK\$100 (No upper limit on the number of miles for each redemption). No handling charge is required for redemption of miles or points of other participating partners of the Travel Reward Program.
12. Bonus Points that are redeemed as miles or points cannot be cancelled or reinstated to Cardholder's credit card account. The miles or points will be transferred to the Cardholder's membership account within 4 to 6 weeks after confirmation on cardholder's application by the participating partners of the Travel Reward Program.
13. Any not posted, cancelled, refunded, ineligible transactions (as determined by the Bank) or the cardholder commits any fraud or abuse in relation to the Travel Reward Program, the Bank reserves the right to take any legal action or charge the cardholder an administrative fee for redemption of miles or points. The fee will be debited from Cardholder's credit card account.
14. The miles or points redeemed by the Cardholder via the Travel Reward Program are supplied by the participating partners of the Travel Reward Program. The Bank accepts no liability for any matters relating to services or quality provided by the participating partners or action taken on their frequent flyer programs.
15. After Cardholder successfully joins the frequent flyer programs of the partners participating in the Travel Reward Program, the rules for their frequent flyer programs will be mailed to the Cardholder. Cardholder is subject to and must comply with such rules provided by the partners.
16. The participating partners of the Travel Reward Program may change their program rules including regulations, policies, benefits, participating conditions or mileage levels, in whole or in part, at any time with or without notice, even though such changes may materially affect the value of the free mileage already accumulated.
17. The Bank reserves the right to revise the terms and conditions of, change or cancel the Travel Reward Program from time to time without prior notice to Cardholder.
18. In case of discrepancy between the Chinese and English versions of these terms and conditions, the Chinese version shall prevail.
